- or minors up to the age of 12 and elderly people over the age of 75 on the date of the start of the stay;
- or disabled people with disabilities who present the relevant documentation, any companion and parents;
- or the sick, who must carry out medical visits, treatments or therapies in day hospital at healthcare facilities, as well as those who assist patients admitted to healthcare facilities, at the rate of one companion per patient. In the case of sick people under the age of eighteen, both parents are exempt. The patient or companion must declare, on a specific form prepared by the Municipality and provided by the manager of the accommodation facility, pursuant to articles 46 and 47 of Presidential Decree no. 445 of 2000 and subsequent amendments, that the stay at the accommodation facility is aimed at receiving healthcare services from the patient or being able to provide assistance to the patient;
- or students and school groups who participate in educational trips with schools or training institutions and their accompanying teachers;
- or subjects staying in accommodation facilities following measures adopted by public authorities, to deal with social and emergency situations resulting from calamitous or extraordinary events or for humanitarian relief purposes;
- or volunteers who serve during disasters;
- or bus drivers and tour leaders who provide assistance to groups organized by travel and tourism agencies. The exemption applies to each bus driver and one tour leader for every 25 participants;
- or personnel belonging to the state and local armed and police forces as well as to the national fire brigade, civil protection volunteers who stay for service needs;

- or those who perform subordinate work for the same structure in which they stay;
- or employees of companies carrying out public works in the Municipality;
  
- or the "volunteers" who offer their social service on the occasion of events and demonstrations organized by the Municipal, Provincial and Regional Administration or for environmental emergencies;

The undersigned declares to be aware of the criminal sanctions in case of falsehood and false declarations, provided for by the art. 76 of Presidential Decree 445/2000.

This certification is issued on the basis of articles. 46 and 47 of Presidential Decree 445 of 2000 and subsequent amendments and delivered to the manager of the accommodation facility.
